The Chichester Place Plan recognises the need for "support to assist with developing a plan for Selsey beach front and an economic delivery programme..". The WSSC programme is reviewed annually but the Haven cannot be proposed at present as the various reports commissioned have not been considered by CDC yet.	Tentative
Big Lottery - Reaching Communities	Applications eligible from Local Authority; not for profit (e.g CIC) or a partnership which is not-for-profit led. Communities benefitting must be involved in project development. Focus on sustainable changes to places/spaces; strengthening community relationships; tackling root causes of social problems	Specific sections of the Selsey Haven project may be eligible, although not the main sea-based infrastructure. Capital funds up to £100k including refurbishment and land/buildings purchase. No new applications until April 2018. Reaching Communities Buildings strand of lottery funding was also explored but it now closed and under review, and may prove relevant in future. EAFRD (European Agricultural Fund for Rural Development)		This is the DEFRA wing of EU funding, managed by the Rural Payments Agency. EAFRD funding was suggested as a funding source for projects arising from the Marshall Regen Socio Economic Assessment. The main potential funding source is RDPE Growth programme (see below). The postcode for Selsey Haven (PO20 0SZ) passes the Rural Payment Agency's (RPA) "Magic Map" eligibility test. LEADER (also see below) may also be relevant.	See below

Coastal Communities Fund Round 5	Government has confirmed that the fifth round of the Coastal Communities Fund for 2019 to 2021 will provide at least £40 million over 2019-21 to coastal areas in England for economic regeneration and growth, creation of/safeguarding jobs. It will be open for applications in early 2018.	Selsey Haven as a wider project may be eligible for partial funding from the CCF Round 5 in 2018. Round 5 information to be released over Jan/Feb 2018 and two stage application process anticipated, with applications from 1/4/18. Methodology/timescales for Round 4 are shown below as a guide for Round 5. For Round 4, construction projects required planning permission and other consents such as EIA to proceed to a Stage 2 full application. Average project spend to up to 2016 under the CCF has been £600,000 with some £20.6M allocated to projects in the south-east. CCF Round 5 will be launched in the next few weeks with the funding available from 1 April 2019. All application materials, including guidance notes and forms, will be available at the launch and a series of pre application Webinars is planned to enable applicants to seek further information regarding the application process. EMFF is divided into streams. Aspects of Selsey Haven will be eligible for partial funding from different streams notably - 3 Investments to Shore Based Facilities (including fishing ports, landing sites, auction halls and shelters); 4 Partnerships and information sharing; 5 Seafood processing; 6 Aquaculture farming and inland fishing. Funds for Marketing and Processing are currently suspended due to high demand, with further advice awaited in 2018. Funding ends in 2020, or once available funds have been allocated.

Planning application has to be approved before a capital project is considered eligible. Development costs will not be considered. May not be able to offer sufficient funds - the different streams are capped at different levels - e.g Shore Based facilities is capped at £1million - though more than one fund can be applied for.

LEADER	Grants for rural businesses and community groups (not local authority). Maximum grants of £70,000 to £100,000. Must be capable of completion by end 2019.	LEADER funding provides grants of up to £75,000-£100,000, will fund capital spend and contribute 40% for private sector projects, and sometimes more for a community project. Selsey is within the Sussex Downs and Coastal Plain LAG area where priorities are rural tourism, jobs, rural business development including workspace, local food and drink sector. Projects require a completion date of December 2019. This means applications to LEADER must be submitted by Oct 2018. Flood and Coastal Erosion Risk Management Grant in Aid (FCERMGiA)	Grants depend on number of households protected from flooding and any claims need prior Environment Agency approval. Match funding required; EU funds cannot be used for this. European Social Fund (ESF)	Funds focus on inclusive labour markets, social exclusion and skills.	There are no open calls for ESF funding currently but C2C are expecting DWP to launch a Direct Call for £8.89 million ESF funding for the LEP area early in 2018 comprising £6.91M for Inclusive Labour Markets and £2.8M for Skills for Growth. ESF is the European Union's main financial instrument for supporting employment in member states as well as promoting economic and social cohesion. Interreg 2 Seas Call 6	Criteria not yet available	Interreg funds projects which stimulate cooperation between regions in the European Union, and is funded by the European Regional Development Fund. Interreg VI will be open from 1 February until 2 May 2018 with calls for proposals and funding details made available. During this period, applicants will have the chance to submit a Concept Note which explains the strategic outline for a project. It contains information on the partnership and overall budget, the proposed objectives, outputs and results and the contribution to the Programme.	Uncertain, but only 'co-operation' projects.
